With a population of just 4000, this remote 64 square mile Polynesian island is a part of the Chilean territory located over 2000 miles from the mainland. Easter Island is famed for it's very rich and unique archaeology including nearly 1000 "moai" – monumental statues created by the Rapa Nui people during the 13th-16th centuries. The moai are carved human figures with oversize heads, often resting on massive stone pedestals .

If one picture is worth a thousand words, just imagine yourself standing among these stunning figures dressed as Santa Claus!!

In addition to extensive sightseeing, you will make a Santa goodwill visit and partake in other fun activities during your three days on the island.
